


CSR at Century



Century, with the help of local authorities distributed ration among needy people of surrounding communities and also donated Protective Equipment to Health Workers of the vicinity.




CURRENT INSTALLED CAPACITY (Product Category Wise Break Up – TPY)



This current announced Capacity 240,000 TPY is expected to increase by around 15 % within this years, mainly for Coated packaging Board.




Century – Market Share - Coated Packaging Boards

COVID-19 related SOPs and Preventive Measures

After the outbreak of COVID 19 pandemic, Century Paper was immediately resorted to implementation of SOPs to prevent spread of virus at one side and to ensure smooth operations on the other side.

Following measures were implemented at Mills and different offices:-

- Distribution of Protective Equipment to Health workers in the vicinity





























Production (M. Tons)






Sales Volumes (MT) & Gross Sales (PKR -Millions)





EBITDA (PKR -Millions) & ROCE (%)







Turnover & COGS (PKR - MLN)






Gross Profit and Operating Profit (PKR -MLN)








Finance Cost and Net Profit (Rs.' MLN)

Overall Market

- Over all Market Size of Paper & Paperboard contracted in two consecutive years:
 - 2018-19 3% Drop
 - 2019-20 6% Drop
- Likelihood of any further contraction in 2020-21 is low as market is now in recovery phase.
- A moderate growth over last year market size is expected in 2020-21.
- Curtailed imports neutralized negative impact of market size contraction on domestic Industry.





Packaging Board

- Packaging Board's demand stayed slightly positive in last two years when overall market was contracting.
- In post COVID19 scenario Packaging Demand is expected to stay stable rather improved.
- Changing life style and health consciousness is leading to increased use of branded and packed food items in particular.



Writing/ Printing Paper

- Writing Printing Paper market may stay under pressure for quite some time due to:-
 - Increasing paperless working trend in corporate sectors
 - Prolonged closure of educational institutions.
- CPBM have very low stake in paper biz as only 7% of the capacity is for Paper Biz
